- iv) The office of any trustee will be vacated by his or her death or by his discharge from his/her office by the Board of Trustee. In case death of a trustee any member of his / her family or any one else will be nominated as trustee by the Board of Trustee.
- v) The trustees shall have power and authority to appoint or engage and at their discretion remove dismiss or suspend any employee, official or servant in connection with the work of the trust, trust estate, trust fund and trust properties as they may from time to time think fit and to determine their powers and duties and fix their salaries and emoluments and other conditions of such service.
- vi) The meetings of the Trust Board will be convened twice a year to discuss the various programmes/activities conducted by the Trust in a period not exceeding six months gap between two consecutive meetings. A Notice will be issued before 10days for holding general meeting and in case of

Emergency meeting notice will be issued at least before 3 days of the said meeting.

- vii) The meeting of the Trust Board will not be convened if the two third members of the Trust are not present in the meeting.
- viii) If two third members of the Trust pass resolution that any member of the Trust is involved in anti-organizational activities and immoral conducts and his continuation is prejudicial to the Trust. The he/she will also lose her or his membership.
- ix) Incase any member of the Trust voluntary offers his/her resignation expressing his/her unwillingness to continue as member of the Trust he/she will lose her membership.
- x) In case of any dispute / problem arising against the Trust the jurisdiction about the legal action is within the jurisdiction of Cuttack district only.

5) TRUST FUND:

- i) The amount of Rs.10,000/- contributed initially by the Settler as aforesaid.
- ii) Amount received by way of donations, beneficence or contributions from the Settle or members or any other person, Firm, Society, NGO, company, Trust or other institutions.
- iii) Subsidies or Grant-in-Aid / Financial Assistance received from the State / Central Govt., foreign funding agencies, Trust, NGO, Local Authorities etc.

- iv) Interest accruing or deposits made by the Trust from time to time
- v) Funds, from various sources, decided from time to time
- vi) The return or yield by whatsoever named called of the investments made from time to time by the Trust.
- vii) Funds from Indigenous sources.
- viii) The fund of the trust shall be utilized only towards charitable purposes as aforesaid in India and any accumulation of means shall also be made and deemed to be made for application to such charitable purpose as aforesaid in India in accordance with the provisions of Income Tax Act, 1961.
- ix) The Trust shall be maintained all accounts of the Trust regularly, the accounts shall be audited by an auditor every year.

6. POWER & FUNCTIONS OF THE CHAIRMAN.

- a) The management and affairs of the Trust shall vest in the Chairman who will represent the Trust or its institutions before all courts and authorities and exercise such powers as is necessary for conducting the affairs of the Trust, or its institutions, with powers to nominate and whose decision in all matters shall be final.
- b) To decide all questions arising in the administration of the Trust hereof and including all questions relating to the interpretations of those presents, the administration of any institutions maintained by the Trust or concerning anything any matter to or connected with or arising out of these presents or the operation thereof. The decision of the Chairman on all or any of the matters aforesaid shall be final.

- c) To appoint and dismiss and reappoint executives, teaching staff, officials Engineers, Doctors, nurses, clerks, care takers, attendants and other employees on such salary and on such terms as they may think fit.
- d) To deposit by way of safe custody and documents held by them relating to any property belong to the Trust with any bank and to pay any sum payable in respect of such deposit.
- e) The Chairman and Member Trustee is hereby authorized to invite or accept donations of money, shares, debentures, bonds and other movable and immovable properties from the Author/ Settler or any one else by way of gift, grant, legacy, or otherwise or such terms and conditions as they may think fit not being inconsistent with the terms and conditions of these presents and such donations shall be held by the Chairman as accretion and augmentation of the Trust Fund.
- f) Whenever necessary the Chairman may opt to retire or otherwise will have power to nominate his successors to be noted in the resolution of the of the board of Trustees and the successor so chosen will have all rights and liability like any other trustees. Such nomination may be changed from time to time.
- g) The Chairman shall be solely responsible to purchase, construct, or hire or take on lease any immovable or movable property for all or any of the purpose of this Trust at such price, cost or rent and on such terms and conditions and for such period and with or without options for renewal as he deems fit. In case the immovable property owned by the Settler or Chairman or including the member Trustees, is taken on lease, the rent payable shall not exceed the fair market rent, as assessed by the

local authority or fixed by a well recognized or well known real estate dealer of the locality.

- h) Where the Chairman in the purported exercise of the Trusts, discretions and power, hereby or by law conferred, act on the advice of any counsel solicitor or other lawyer, engineer, surveyor, land or estate agent, actuary or broker, cashier or Accountant of expert, they or other trustee (s) shall not be responsible for any loss that may result from acting on such activities but the act of commission shall be deemed to be authorized and proper, and the advice shall operate to protect the Chairman and other Trustee (s) in the like manner as if the act or commission shall be deemed to be authorized ~~and under~~ an order of a Court of competent jurisdiction.

The powers so vested will be exercised by the Chairman and one the trustees jointly or severally or singly wherever it is necessary and such exercise of power will not invalidate any transaction.

- i) The Chairman and the authorized trustee are hereby vested with the power to open and operate Bank accounts jointly in any Nationalized Bank or any other schedule bank and borrow or ~~raise any amount of money required by the Trust upon such terms as may be deemed fit by them.~~
- j) The Chairman and one of the trustees are vested with the power to let out, lease, devise mortgage, charge or license any property belonging to the trust ~~for such rent or compensation and on such terms and conditions and for such period as they may think fit.~~
- k) The Chairman is vested with the power to reimburse themselves or pay and discharge out of the funds or any property subject to

the terms of these presents and income thereof, all expenses that may be incurred in or about the execution of the trusts and powers of the Trustees including requisite amount of traveling expenditure incurred for attending any activities of the Trust.

l) Upon any sale or other transfer by the Chairman under the power aforesaid the purchaser to purchasers, transferees (s) dealing bonafied shall not be concerned to see or enquire whether the occasion for executing or exercising such power has arisen or whether the provisions and to the appointment and retirement of trustees. Herein contained have been property and regularly observed and performed except that the decision to sell the properties has been taken in accordance with these presents. Neither shall be purchaser or purchases, transferee or transferees be concerned to see to the application of the purchase money, or other consideration or be answerable for the loss misappropriation or non-application thereof. The purchasers shall get a valid title in respect of properties purchased in good faith from the Chairman.

m) Subject to any mandatory provisions of any law for the time being in force and applicable to the Trust, the Chairman shall invest all moneys which shall require investment in any investments or properties of whatsoever nature and whatsoever situate and whether involving liabilities or producing income or not or upon personal credit with or without security and in the manner authorized by law and the Income Tax Act, 1961 for the investment of the Trust funds and to call, convert for exchange such investments and properties, both movable and immovable whenever, they in their absolute discretion, thinks it desirable to do so.

- n) The Chairman is vested with the power to decide all matters pertaining to admission of students of any institute managed by this Trust. Their decision in this regard shall be final.
- o) To compromise compound, abandon, submit to arbitration or otherwise settle any actions, suits, proceedings, debts, claims or things whatsoever arising out of the administration of the Trust Fund, or any instruction maintained and for any of these purposes may enter into, give, execute and sign agreement, instruments, arrangements, releases and other things as may seem to them expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith as fully as in they were absolutely entitled to the Trust Fund and the said institutions without being answerable for any loss, occasioned in good faith.
- p) The Chairman will have all powers of Board of Trustees when the Board of Trustees are not in sitting in the meeting. The Chairman will exercise the powers of the Board of Trustees.

7. POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES.

- a) The Trustees may meet together for taking decision as to the work of the Trust, adjourn in and or otherwise regulate their meetings and proceedings as they may think fit. A resolution passed by circulation without any meeting of the trustee(s) and evidenced by writing under the hands of the majority of the trustees shall be valid and effectual as a resolution duly passed by a meeting of the trustee(s) held in accordance with the provisions of these presents. In case there is more than one Trustee then the Board of Trustees. Notes made in the Minute Book relating to the Trust shall be conclusive evidence of the

facts and matters noted therein. The trustees(s) shall keep receipts and expenditure relating to the Trust Fund and any other institutions maintained or run by it.

- b) To delegate by power Authority or otherwise by way of resolution to any trustees or Trustees or any other person or persons, powers and authorities implied by law or conferred by statute on vested in the Trustees by these presents. The Trustee(s) shall however not held liable nor responsible for the acts or defaults of any such person or persons but only for their own respective acts and defaults.
- c) To set up one or more Managing Committees/Governing Council from amongst themselves or other persons nominated by the Trustee(s) for the routine and day by day management and administration of any such institution under their ultimate supervision any control. The members of such Committees / Councils shall be nominated for a period not exceeding two years. The Trustee(s) shall be entitled to frame the Constitution and regulate the procedure of such committee and to delegate to them such powers as he/they may consider proper and necessary. The Trustee(s) will also decide about the quantum of sitting fee and traveling allowance to be paid to the nominated Council /Committee members.
- d) To frame such rules and regulations for the management and make administration of regulations set up by the Trust as they think fit and to alter or vary the same from time to time and to make new rules and regulations provided that such rule and regulations shall in no case be inconsistent with the terms of these presents.

- e) To appoint any Advisory Committee to help the Trustee in the management of the affairs of the Trust or any institution maintained or run by it and the discharge of their duties on such terms and conditions as they may determine.
- f) To transfer all the assets of the Trust Fund to any other Trust or institutions having objects similar to those of this Trust in the event of the Trustees unanimously coming to the conclusion that they are unable to continue to manage the affairs of the Trust.
- g) To do all such other lawful things as may be incidental or conducive to the attainment of the objects of the Trust.
- h) For the receipt of any money paid or any stock funds or securities or other investments transferred to them in the execution of any of the trust or powers hereof or for the purpose money paid to them, the Trustee shall effectually discharge the person or persons paying or transferring the same there from.
- i) The Chairman or after trustees shall not be settled to use or apply any Trust property or income thereof for his/their personal benefit in lieu of or for remuneration (and assistance) of the services rendered or to be rendered by him/her or them of the Trust except that remuneration has been provided for in this Trust.
- j) The Chairman will implement the resolution passed by Board of Trustees within the powers conferred upon him.

8. **AMENDMENT OF THE CLAUSES:**

The Settler of the Trust will have no power to revoke the Trust deed, and also he shall have no power to amend, alter and abridge the memorandum of Association and Rules and Regulations which may prove to be repugnant to the provisions of Section 2(45) 11 to 13 and 20G of the Income Tax Act, 1961 and also powers of the Managing

WHEREAS the party of the First Part is the absolute owner of land and building situated at Plot No.1107, Mahanadivihar, Cuttack-753004 and the said party of the First Part is desirous of letting four rooms on monthly rent basis, and

WHEREAS the parties of the Second Parts being a business women is in need of residence cum official accommodation for the same and approached the said party of the first part for letting out the four rooms on monthly rent basis w.e.f.01.08.2016 and.

WHEREAS the parties hereto after having negotiation decided to reduce terms and conditions of the agreement into writing of this agreement.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. That the party of the First Part will let out the three rooms to the party of the Second Part for a monthly house rent of Rs.7,500/- (Rupees Seven Thousand Five Hundred only) (Excluding Electricity charges) which shall be payable to the First Part within the 1st week of each succeeding calendar month in full, failing which tenant shall be considered to be the defaulter.
2. That this agreement will remain valid for three years. If the landlord feels satisfied with the tenant in abiding with terms and conditions of this agreement the landlord is at liberty to enter into another fresh agreement.
3. That electricity dues any other local dues etc. shall be paid by the tenant according to the meter reading and bill raised by the CESCO and at no point of time the Landlord shall be held liable for such payment. The Land Lord shall have no objection if the tenant directly avail electric connection in his name from CESCO.
4. That, the party of the second part shall give advance rent i.e.Rs.20,000/-(Rupees Twenty Thousand only) to the 1st party which is interest free and refundable after vacation of the house and handing over complete possession on same condition as taken by the tenant during occupation.

6. That the tenant shall not transfer the tenancy or subject the whole or any portion thereof to any other businessman nor shall carry on any immoral trade or business of storing hazardous materials.
